New rules on the securities market as of 3 January 2018

As of 3 January 2018, the protection of investors in securities was further strengthened by two new regulations, MiFID2 and MiFIR, which aim to increase transparency in the financial markets and provide you as a customer with increased protection. Part of this protection is that Mangold must ensure that the products you buy are suitable for you and that you belong to the target group for the product. As part of this, Mangold needs to obtain certain information about your knowledge and experience of the securities market, your ability to bear losses and your risk appetite, which is done through the questions below.

Questions on knowledge and experience are to be answered by the person who decides which transactions are carried out on behalf of the client (client or authorised representative), questions on ability to bear losses should be answered in relation to the client's financial situation.
